- One Chromebook device, and charger are being loaned to the Student/Borrower and are in good working order. It is Student/Borrower's responsibility to care for the equipment and ensure that it is retained in a safe environment.
- This equipment is, and at all time remains, the property of Saint Albert Catholic Schools, Council Bluffs Iowa, and is herewith lent to the Student/Borrower for educational purposes only for the academic school year.
- Student/Borrower may not deface or destroy this property in any way. Inappropriate use of the device may result in the Student/Borrower losing his/her right to use this computer.
- The equipment will be returned to the Saint Albert Catholic Schools if the Student/Borrower withdraws from Saint Albert Catholic Schools prior to the end of the school year.
- The School Property may be used by Student/Borrower only for noncommercial purposes, in accordance with the School policies and rules, School Code of Conduct, as well as, local, state, and federal statutes.
- Student/Borrower may not install or use any software other than software owned or approved by the Saint Albert Catholic Schools and made available to Student/Borrower in accordance with this Receipt and Agreement.
- One user account with specific privileges and capabilities has been set up on the Chromebook device for the exclusive use of the Student/Borrower to which it has been assigned. The Student/Borrower agrees to make no attempts to change or allow others to change the privileges and capabilities of this user account.
- The Student/Borrower agrees to make no attempts to add, delete, access, or modify other user accounts on the Chromebook device and on any school-owned computer.
- The Saint Albert Catholic Schools network is provided for the academic use of all students and staff. The Student/Borrower agrees to take no action that would interfere with the efficient, academic use of the network.
- Identification and inventory labels/tags have been placed on the Chromebook device. These labels/tags are not to be removed or modified. **If removed or modified you will be charged \$5.** If they become damaged or missing, contact tech support for replacements. Additional stickers, labels, tags, or markings are not to be added to the Chromebook device.
- Chromebooks will be checked once a month during advisory to check for label, damage and that students are keeping them charged.
- A Google Apps for Education account is available for each Student/Borrower to use for appropriate academic communication with other students and staff members.
- Iowa statute allows the School to obtain reimbursement from, or on behalf of, students for any damage to, loss of, or failure to return School property. The full cost of the Chromebook device is \$225.
- Student/Borrower acknowledges and agrees that his/her use of the School Property is a privilege and that by Student/Borrower's agreement to the terms hereof, Student/Borrower acknowledges his/her responsibility to protect and safeguard the School Property and to return the same in good condition and repair upon request by Saint Albert Catholic Schools.
